

# Winter Vacation Camp

We will open the middle school with fun & games at 8:00 am each day and we will stay open until 5 pm regardless of what time the bus returns to Raymond. The cost for the winter camp is \$150 for the entire week plus an additional fee if you need to purchase our vacation camp shirts. If you only want to attend a few days, you may also register for individual days, \$30 for playground daze, \$45 for snowtubing, \$45 for rollerskating and \$45 for trampoline park. Children are required to wear either their vacation camp or summer playground shirt on each trip day. We will attempt to hold camp in the event of inclement weather. We may however, have to change the event for that day. Non-resident's fee is an additional \$20 per week or additional \$5 per day. The last day to register is Thursday, Feb. 22<sup>nd</sup>.

## RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

In consideration of the permission granted to the participant named above to participate in the RAYMOND RECREATION FIELD TRIP, I/we SHALL RELEASE, WAIVE DISCHARGE AND COVENANT NOT TO SUE the Town of Raymond, Recreation Department, their agent and employees from all liability for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the named participant except in the case of gross or willful wanton negligence of the Town of Raymond, Recreation Department its agents and employee or otherwise while the named participant participates in the RAYMOND RECREATION.

I/we further agree to indemnify the Town of Raymond, Recreation Department, their agents and employees from any and all liability, loss or damage including but not limited to bodily injury, illness, death or property damage which the Town of Raymond, Recreation Department, their agents and employees become legally obligated to pay including reasonable attorneys' fees and costs, as a result of claims, demands, costs or judgments, against the Town of Raymond, Recreation Department, their agents and employees on account of injury to the person or property or resulting in the death of the named participant except in the case of gross or willful wanton negligence of the Town of Raymond, Recreation Department, their agents or employees and whether or not such liability is sole, joint or several.

I/we am aware that participation in this program may present a strain on my child's body, or its parts and therefore I represent to the Town of Raymond, Recreation Department that to the best of my knowledge, my child is in a proper physical condition to allow him/her to participate and that I/we assume the risk of participating. I/we understand that the above program involves traveling to various activity sites. I/we will accept full responsibility for the transportation of my child to and from these activities and I/we release, indemnify and hold harmless and persons providing such transportation. I/we understand that in case of injury or illness, I/we will be notified. If it is impossible to contact me and it is an emergency, I/we hereby give permission to the attending physician to treat, hospitalize, administer anesthesia, or to order injections or surgery for the safety of my child.
